Flyers have been made and will be brought to next month's meeting. Brittany will share with the other 4-H leaders.

Further discussion surrounded potentially changing our name since the name itself might be a deterrent. We felt that it is too late to make a change for this season and if we do make a change, we want to be thoughtful about what the new name would be. We will come up with new name ideas this season and look into making a change by 2019 if the advertising this year doesn't seem to bring in more participants.
