Meeting was called to order at 6:03 pm.

Roll call of officers: The Treasurer, Susan was out.

Secretary's report: August's minutes were approved as read.

Treasurer's report for August - The Royalty has \$762.40 in their account. We have \$7,554.49 in Savings after receiving .19 cents in interest, giving us a total balance of \$17,322.99.

There was a concern brought up about the language an exhibitor was using. Paige did address that with the individual. Another concern was brought up about the age of the individuals leading the horses in the leadline class. We need to abide by the rule of an older person leading the horse for safety reasons.

Show Report: Reported that Beth Smith will be the September judge. Look for the patterns to be posted to the web. Ranch Riding will be held at this last show of the season.

Old Business: Josh White was able to secure a donation of wood for the bleachers, we will work on that project in the spring. Jeff Mott mentioned he is still not receiving emails. Paige will check on this again to figure out the problem.
