

## Johnstown Saddle Club February 6, 2021 Minutes

Meeting was called to order at 6:05 pm.

Roll call of officers: All officers were in attendance.

Secretary's report: The October 3rd, 2020 minutes were approved as read.

Treasurer's report October - The Royalty has a negative \$68.99 in their account after paying for the buckles which were \$655. We have \$5,312.19 in checking after depositing \$200 in the form of a donation from Stone Canyon and \$473 from the Fun Show. We paid \$50 to Grace Place, \$500 for banquet rental, \$2,665 to A Cut Above for buckles, \$655 for Royalty buckles, \$1,769.04 to Custom Tack for awards and \$1,205 to Alamo Saddlery for awards. We have \$2,552.36 in Savings after receiving .10 cents in interest, giving us a total balance of \$7,864.55.

November's report - The Royalty has \$1,061 in their account after receiving \$1,130 from the auction. We have \$4,869.19 in checking after depositing \$1,130 from the auction. We paid a total of \$158 in "bucks" reimbursement and \$1,338 to Alamo Saddlery. We have \$2,552.47 in Savings after receiving .11 cents in interest, giving us a total balance of \$7,448.66.

December's report - The Royalty has \$687.89 in their account after receiving an additional \$80 from the auction and paying \$453.12 for their crowns. We have \$4,523.07 in checking after depositing \$80 from the auction and paying \$453.12 for crowns. We have \$2,552.57 in Savings after receiving .10 cents in interest, giving us a total balance of \$7,075.64.

### **Note: Correction to what was read and approved at the last meeting**

January's report - The Royalty has \$687.89 in their account. We have \$4,764.07 in checking after depositing \$360 in member dues and paying \$63 to United Waste and \$56 for our postbox rental. We have \$2,552.68 in Savings after receiving .11 cents in interest, giving us a total balance of \$7,316.75.

Royalty report: Cambree reported that the Royalty received numerous donations. They are; Red Barn Liquor for \$250, Hall Chiropractic \$200 and Mountain View Ortho for \$50. The royalty has nothing else of significance at this time to report.

Old Business: None.

New Business: Paige went over the rules regarding dogs as this seemed to get out of hand last year. Susan's dogs are the only ones to be on the property due to the fact it is her arena. Outside dogs are not allowed, we ask our members to obey this rule and notify other guests of this rule.
