

Johnstown Saddle Club January 6, 2026 Minutes

The meeting was called to order at 6:01 pm.

Roll call of officers: All officers were present.

Secretary's report: October's minutes were approved as read.

Treasurer's report – October's report – We started with \$1,997.64 in Checking; we had one deposit of \$564.00 and eight withdrawals totaling \$208.03 giving us an ending balance of \$2,253.61. We started with \$4,451.43 in Savings; we had one interest deposit of \$2.07 giving us an ending balance of \$4,453.50. The total club balance was \$6,707.11. The Royalty checking account had a beginning balance of \$340.47, they had one deposit of \$238.00 and four withdrawals totaling \$351.81 give them a final total of \$226.66. In their Savings they had a beginning balance of \$50.35. They had three deposits totaling \$2,370.00 and one withdrawal of \$238.00 giving them an ending balance of \$2,183.02. The total balance of their two accounts was \$2,409.68.

November's report - We started with \$2,253.61 in Checking; we had one deposit of \$2,953.00 and three withdrawals totaling \$1,165.25 giving us an ending balance of \$4,041.36. We started with \$4,453.50 in Savings, we had one interest deposit of \$1.43, and one transfer of \$2,953.00 giving us an ending balance of \$1,503.93.

The total club balance was \$5,543.29. The Royalty had a beginning balance of \$226.66 in Checking and two withdrawals totaling \$31.45 giving them a final balance of \$195.21. In Savings they had a starting balance of \$2,183.02 and two deposits totaling \$501.10 (\$1.10 was interest) giving them \$2,684.12. The balance of their two accounts was \$2,879.33.

December's report - We started with \$4,041.36 in Checking, twelve withdrawals totaling \$3,345.43 giving us an ending balance of \$695.93. We started with \$1,501.93 in Savings, we had one interest deposit of \$.62, giving us an ending balance of \$1,502.55. The total club balance was \$2,198.48. The Royalty had a beginning balance of \$195.21 in Checking; they had three deposits of \$440.00 and four withdrawals totaling \$406.11, giving them an ending balance of \$229.10. For their Savings account, they had a starting balance of \$2,684.12, they had two deposits totaling \$1,101.41 and three withdrawals totaling \$440.00 giving them an ending balance of \$3,345.53. The total balance for the two Royalty accounts was \$3,574.63.

Royalty report: Introduction of Addison Lambert as the Junior Queen and Amberly Fender as Junior Princess. The Royalty will be participating in the Stock Show parade on January 8th at noon. Deb Gonzales reported that Emma will try her best to continue as the Senior Queen given her mother's health. Old Business: Discussed the awards banquet; we roughly made \$1,700 in the silent auction and will report the final total at February's meeting. We also ended up with more food than was anticipated. Members appreciated the awards given and photo area.

New Business: The Royalty has two dates at the Boulder County Fairgrounds, April 26th and October 31st. Deb announced that their Gymkhana will be held in the indoor arena. We have another weekend in July at this venue and will consider running shows and/or clinics. The ground was discussed at George's and Kari will be working the ground as consistently as possible.

Kari discussed the website and her conversation with Julie Seat who maintains it for us. A motion was made and seconded that we pay Julie \$230 for her design, maintenance and two domains (the domains are \$15 each). Motion was approved.

New Members: Alyssa and her daughter joined and will be participating in the Gymkhanas. Katie and her son Stetson competed with us last year in the shows and has joined our club. Welcome to our new members.

Member Time: A concern was brought up about the sizing of award jackets given. Unfortunately, some companies run smaller in sizing than others.

Bills to be paid: Grace Place rental and upcoming Insurance for the year.
